TERMS AND CONDITIONS
FOR THE USE OF THE FCRT YARD AND INDOOR/OUTDOOR SCHOOLS

1. All FCRT locations are **STRICTLY NO SMOKING.**
2. **DOGS MUST BE KEPT ON LEADS AT ALL TIMES. NO DOGS ARE PERMITTED IN FCRT BUILDINGS INCLUDING THE INDOOR AND OUTDOOR SCHOOLS.**
3. **CHILDREN MUST BE SUPERVISED BY A RESPONSIBLE ADULT AT ALL TIMES.**
4. **HARD HATS MUST BE WORN** at all times when mounted.
5. **Horses must have a current Equine Passport, including an up to date Equine Influenza/Tetanus vaccination.**
6. Please park lorries or vehicles with trailers facing the long side of the indoor school to allow for maximum vehicles to park. **Please do not park lorries or trailers in the areas at either end of the outdoor school.**
7. No unloading/loading onto/from the concrete aprons in front of the loose boxes.
8. Cars should be parked in the car park situated at the end of the indoor school, which is clearly marked just as you are about to enter the yard.
9. No trotting on the yard.
10. Please do not ride along the concrete aprons in front of the loose boxes or McNaught House – these areas are very often slippery.
11. Please clear up all droppings and loose hay. In the case of the new school surfaces, please – if possible – pick up droppings as soon as they are done. Please avoid taking up too much of the surface with the droppings. If you fill the skips, please ensure they are emptied on to the muck heap and are left empty for the next person/group to use.
12. Please do not allow visiting horses to drink from FCRT water buckets.
13. Loose boxes or the wash down area must not be used without permission from the member of staff in charge of the yard.
14. There should be no more than eight horses in the indoor school at any one time (maximum of ten in the outdoor school).
15. When horses are entering or leaving the indoor school the outer sliding door and the inner half doors must be fully opened before passing through.
16. If horses are in the school the doors must be closed and re-opened (and shut) as more horses enter.
17. When riding in the school, please adhere to the 'Rules of the School' as displayed on the white notice on the outer sliding door at 'A'.
18. If riders are removing coats/jackets, please dismount to do so.
19. Horses without riders must not be left standing without anyone holding them!

We realise that some of these rules may seem unnecessary to people who are used to riding independently, but would draw your attention to the following: The FCRT is a Residential Specialist College, providing Further Education Through Horsemastership for young people with special needs. Health and Safety regulations and Risk Assessment must satisfy criteria laid down by the Young People's Learning Agency funding authority and Social Services, integral to the approval of this organisation. The FCRT is also an Approved BHS Examination Centre, listed in the 'Where to Train' Directory.
